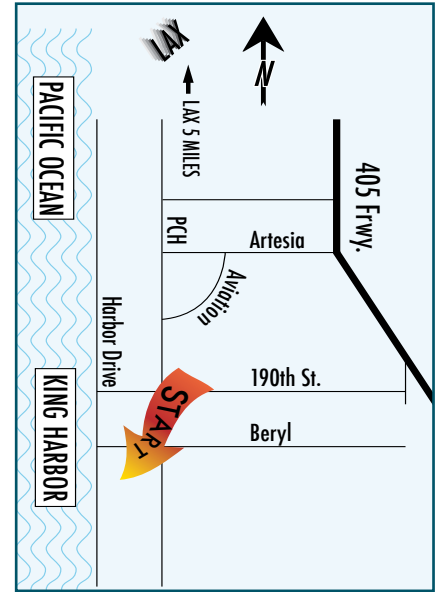

## REDONDO BEACH SUPER BOWL RUN 2020

Vendors must come self-contained and all Vendors sampling any food items must meet the requirements laid out by the San Pedro Health Department.

1. Vendor agrees to have their booth ready for opening of the expo no later than 9:30am, on Saturday and 5:45am on Sunday.
2. Vendor agrees to have their booth staffed during expo hours.
3. Vendor agrees that displays will not physically or visually disturb aisles or adjacent vendors, Spectrum Sports staff will be the final arbiter in any conflicts.
4. Vendor agrees not to sublet space to another company without prior permission from Spectrum Sports Management, which may approve both vendors and the goods/services subletting vendors may advertise.
5. Spectrum Sports Management may change space assignments prior to the event; however Vendor will be given new space at least 72 hours in advance. Every effort will be made not to make changes.
6. Cancellations made up to 2 months prior to the event will receive a refund of 95% of booth payment received. No refunds on deposits or partial payments. There will be NO refunds one month prior to event.
7. Vendor agrees that no refunds will be made to exhibitor who fails to occupy space or show up day of the event.
8. Payment must be made in full prior to the Vendor setting up their expo space. No vendor may move into the space until payment is made and accepted by Expo Manager.
9. Vendor agrees that no vendor shall have authority to incur costs or liability against the race or Spectrum Sports Management and any sponsors associated with the event. Vendor shall be liable for any and all damages that they may cause in connection with his or her booth.
10. Vendor agrees to assume all responsibility for any lost, stolen or damaged goods or for all personal injuries to himself or herself, employees or representatives of Vendor.
11. Vendor agrees that Spectrum Sports Management has the right to refuse, reject or restrict any vendors or exhibits.
12. Any relevant business licenses, city fees or taxes will be the sole responsibility of Vendor.
